FEMA seeks Youth Preparedness Council

Youth from communities across the southeast are encouraged to apply for FEMA's national Youth Preparedness Council.

The council provides an opportunity for young leaders to share their perspectives, feedback, and opinions related to preparedness, and grow their leadership skills while supporting the resilience of their communities.

Students in eighth through 11th grades may apply through a written or video response at <https://community.fema.gov/applytoYPC>.

Youth interested in applying must submit a completed application form, two letters of recommendation, academic records and a list of extracurricular activities. All applications and supporting materials must be received before 9 p.m. on March 8. Students who apply for the national Youth

Preparedness Council will also be considered for Region IV's Youth Preparedness Council.

"FEMA's Youth Preparedness Council is developing the next generation of emergency managers and community leaders. These teens recognize the importance of preparedness and are making their communities safer and more resilient," said Gracia Szczech, regional administrator for FEMA Region IV, which includes the states of Alabama, Florida, Georgia, Kentucky, Mississippi, North Carolina, South Carolina and Tennessee.

The Youth Preparedness Council application website, <https://www.ready.gov/kids/youth-preparedness-council>, was recently revamped with a fresh look and enhanced user experience. Teens are now encouraged to share their academic achievements, ways they have positively influenced their

communities and any leadership experiences.

Council members are selected based on these criteria, as well as extracurricular activities and any experience related to preparedness and emergency management. New council members will be announced in May.

Formed in 2012, the Youth Preparedness Council provides an opportunity for youth leaders to serve on a distinguished national council and participate in the Youth Preparedness Council Summit in Washington, D.C.

During their two-year terms, they will complete both local- and national-level projects and share their ideas on disaster preparedness with FEMA leadership and national organizations.

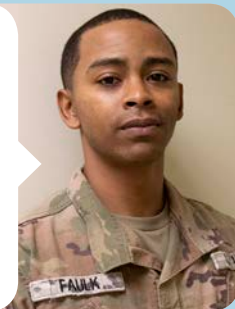

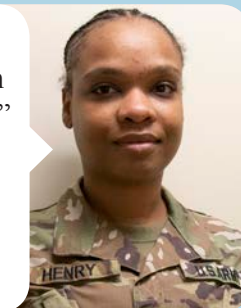

Applicants needed for entry-level security guard positions

Fort Stewart-Hunter Army Airfield's current entry-level security guards will see an increase in their grade and pay thanks to a Department of the Army decision to promote them.

The new rank structure was unveiled to the current security guard force at town halls held Feb. 18 on Fort Stewart and today on Hunter Army Airfield. Beginning March 1, GS-5 security guards eligible for promotion will become GS-6 security guards. Those guards not yet eligible for promotion will have their positions converted. After serving as a GS-5 for a year, they will be promoted to GS-6, Bill Jeffers, garrison resource management officer, said.

"As soon as they hit the one-year mark, that day, they become GS-6s," Jeffers said.

Garrison Commander Col. Bryan Logan said Installation Management Command and the Army have been fighting for this increase in the entry-level grade for a while. The Secretary of the Army approved the changes for security guards in January.

"We know our security guards come in at the five level," Logan said. "It is not competitive. It leaves us short-changed."

The increase in the entry-level grade will help with recruiting security guard applicants. Fort Stewart-Hunter Army Airfield has 124 security guard positions of various

grades, Logan said, with 72 guards currently onboard and 24 new hires coming onboard. That leaves 28 positions available.

"I'm hurting bad on recruitment," Logan said. "We're at 62%. We need good quality individuals to apply for these jobs. As soon as I can get more of you out there, I can take the [military police Soldiers] off and start putting MPs back on the streets and put them back in deployment operations."

New applicants and current security guards seeking promotions to higher levels should go to USAJOBS.gov to find open positions at Fort Stewart and Hunter Army Airfield, Jeffers said.

Fort Stewart's new security guard rank structure is one GS-10, two GS-9s, five GS-8s, six GS-7s, and 58 GS-6s. Hunter Army Airfield's breakdown is one GS-10, two GS-9s, five GS-8s, five GS-7s, and 39 GS-6s.

"Our plan is to fill all of these positions in the upcoming weeks and months," Jeffers said. "The first thing we're going to do is promote all eligible GS-5s to GS-6s."

The goal to promote entry-level guards on staff is by the end of February.

USAJOBS will then open the GS-10 positions for competition, Jeffers said.

"Maybe some of the nines that are here now are going to fill those," he said.

Vacant GS-9s, then vacant GS-8s, and then GS-7s will follow on USAJOBS@gov.

"And after that we'll keep filling the sixes as people get

promoted or leave," Jeffers said.

Logan ended the town hall with thanks for the Department of the Army security guards and reiterated the need to recruit and retain quality guards.

"You take our Soldiers off the gates," he said. "Your presence allows them to do their real job, and what the taxpayers pay them to do, and that's to deploy, fight, and win our nation's wars. I gotta get more of you out there, and I gotta get more of you out there now."

HSC, 3ID Soldiers master convoy protection fundamentals

Soldiers assigned to the Headquarters and Headquarters Battalion, 3rd Infantry Division, maintained readiness by conducting convoy operations during a close combat tactical trainer reconfigurable vehicle system convoy escort exercise, Feb. 7, on Fort Stewart.

This training exercise is one of the first steps in preparing Soldiers for an upcoming convoy protection platform gunnery culminating training event in March, said 1st Sgt. Kenneth Godwin, Headquarters Support Company, HHBN, 3rd ID.

"This training is part of our crawl, walk, run process," Godwin said. "We're familiarizing them with the system by doing dry runs, then making the system a little bit more difficult for them."

The computer-based trainers and instructors at the CCTT create virtual combat scenarios to meet the training

needs of Soldiers. In this case, the Soldiers were put in a convoy escort scenario that tested their warrior skills. Soldiers reacted to enemy contact and practiced sending reports. The training helped them develop crew chemistry while enhancing communication skills.

It is important for Soldiers to have an open and clear mind during the simulation so that they learn something from the experience, said Tim Glaspie, a computer-based trainer and instructor at Fort Stewart.

"The training was helpful, because the 3D images made it feel like a real operation," said Pfc. Desmond Mair, a wheeled vehicle mechanic with HSC.

According to organizers of the training, the goal is for Soldiers to have proficiency in individual, crew-served, and combat platform weapons systems.

"This is something they don't do every day due to the dynamic of our organization, so it's great to give them this training opportunity," Godwin said.

As of Jan. 1, Veterans Health Identification Card and eligible caregivers will now be able to gain access to post. Veterans must register their VHIC at the Visitor Control Center located at Gate 1 on Fort Stewart or at Montgomery Gate VCC at Hunter Army Airfield. Veterans are required to bring their VHIC and a valid driver's license to one of the VCCs for registration purposes. Caregivers with a VA letter can register at one of the VCCs by presenting the letter and a valid Driver's License for registration purposes. Once the registration process is completed, the caregiver will be issued an AIE card to gain access to Fort Stewart and Hunter Army Airfield. Caregivers must renew their AIE cards on an annual basis. Caregivers will be registered as a visitor and anyone traveling with them must either show an approved installation identification card or be screened at the VCC to receive a pass prior to gaining access to the installation.

Estate planning even when you're not deploying

Soldiers frequently downplay the risks associated with everyday life in the Army. They tend to think that death and serious injury can only occur overseas in a combat zone. As a result, they tend to push aside the thoughts about what will happen if they die until right before a deployment or a National Training Center rotation. However, the risks are all around, and Soldiers need to consider whether or not they need an estate plan.

According to a 2018 congressional report, approximately 31.9% of all deaths of U.S. servicemembers, from 2006 to 2018, were the result of some type of accident. These accidents

included training and other routine accidents. By comparison, 16.3% of servicemembers were killed in action during that same time. This means routine training and even driving to the company operations facility should be treated as seriously as a combat deployment.

Considering these everyday dangers, Soldiers should review their estate once a year or after any major life event. A major life event would include the birth of a child, a marriage, a divorce or the purchase of

a new house. Soldiers should also review their will and SGLI coverage prior to a permanent change of duty station move. The travel associated with a PCS move exposes Soldiers to an array of risks they do not normally face, the most apparent being the increase in the amount of time Soldiers spend in a vehicle.

Soldiers tend to not even consider an estate plan because they do not think they have anything of value. But, there are a variety of concerns, other than money, that go into an estate plan. Things Soldiers should consider include:

whether they want to be buried with full military honors, whether they want to be cremated, where they want to be buried, how they want to be cared for if in a vegetative state, and numerous other considerations. Not every Soldier needs a will, but the important lesson from this is that Soldiers should at least take the time to consider whether they need to get a will and put an estate plan together.

If, after some self-reflection, you think you may need to put together an estate plan and get a will drafted, please stop by the Fort Stewart Soldier and Family Legal Services Office where we can help you determine if an estate plan is right for you. Students tour Stewart

Twenty-four students from Georgia High School High Tech took a tour of Fort Stewart, Feb. 13.

When the familiarization period of the weapons tour was over, the students were able to shoot the weapons through a simulated program to get the full effect of shooting a military weapon.

"This was a good, realistic experience and gave good insight [into] what

Soldiers would go through when they train," said Christie Giles, a teacher and chaperone for the students.

During the next stop of the tour, students visited the CFF facility.

At the CFF facility, Soldiers taught the students how to coordinate points on a map and call for field artillery rounds at a particular location to support troops on the ground.

During the demonstration, the students saw a screen where they were able to see the target and saw, based off of their ability to plot points on a map, if their call for fire was successful.

The students said they learned how to plot coordinates in school, and it was really cool to actually see how that would be useful down the road.

"We always love to expand knowledge of students and future Soldiers, so we can set them up for success down the road to increase not only their proficiency, but the Army as a whole," said Sgt. Travis Flynn, a fire support specialist, 1st Battalion, 9th Field Artillery Regiment, DIVARTY.

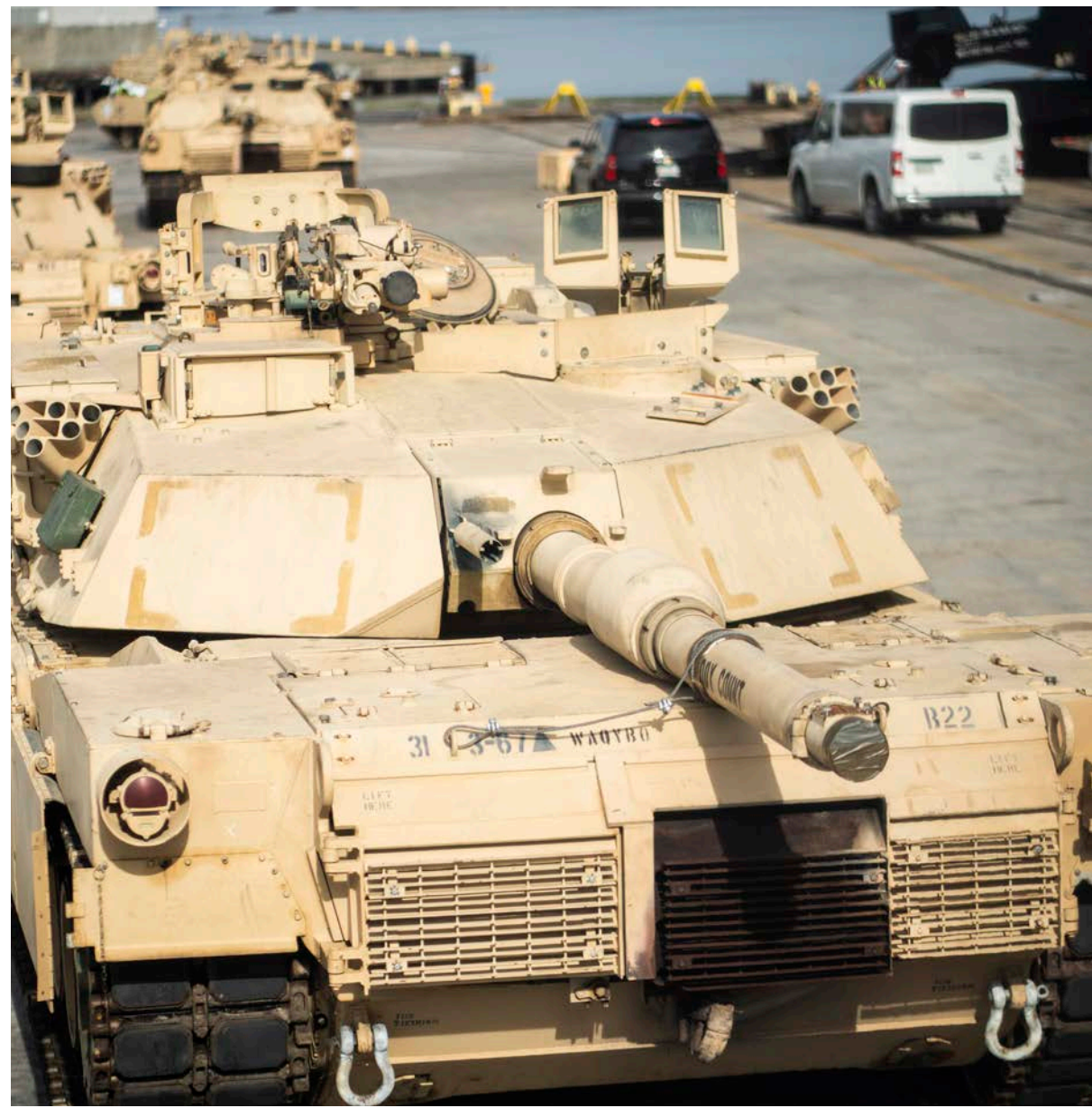

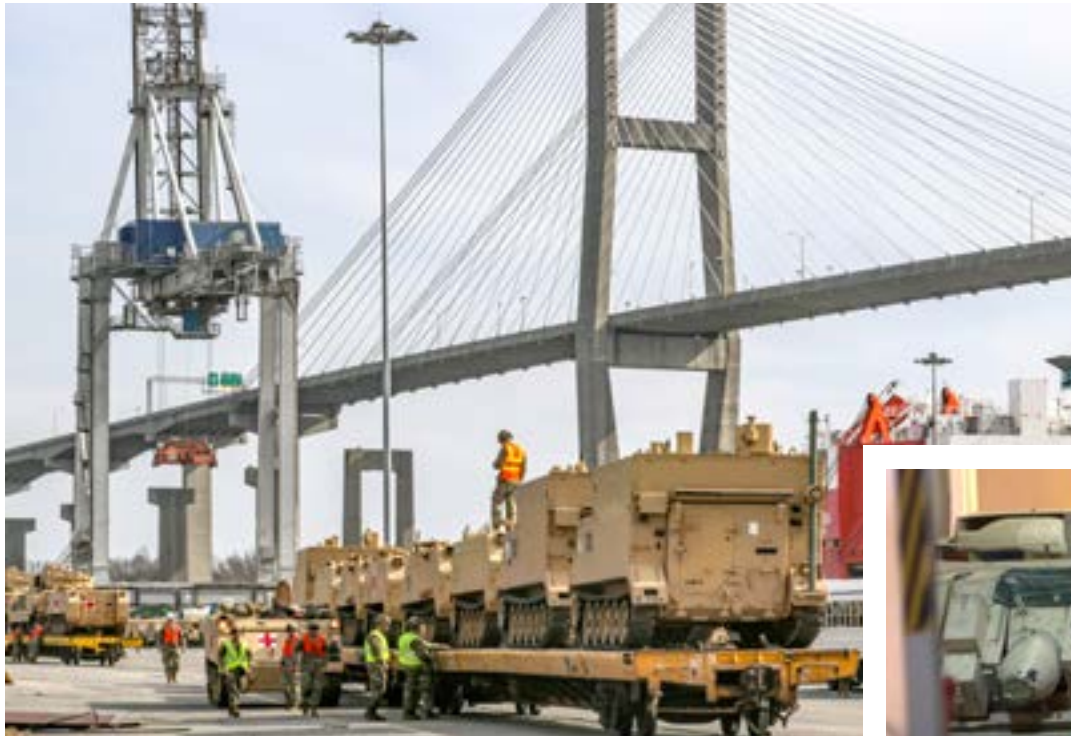

Provider signaleers build on basics

There is an old adage in the Army: shoot, move and communicate. To ensure that the brigade and division forces they support are able to communicate effectively, the 414th Signal Company, 3rd Special Troops Battalion, 3rd Infantry Division Sustainment Brigade, recently conducted training on establishing a tactical communication site in conjunction with an emergency deployment readiness exercise on Fort Stewart, Feb. 10.

"This is the experience the Soldiers need," said Staff Sgt. Matthew Harmon, with 414th Signal Co., 3STB, 3IDSB. "They don't really get this as much as we would like because we have so many other tasks to do. It is good that they get to come out here and train on their equipment. (Now), they have a better idea of what is expected from them if they actually deploy and have to do this in an operational environment."

The training focused on ensuring the Soldiers knew not only how to operate their equipment, but also what goes into establishing a site.

"What I hope the Soldiers learn from this is there is a lot more to this than going out and setting up your equipment," Harmon said. "You've got to plan for your convoy, everything you're going to take and site set up.

There is a whole lot more than just going out there and pushing some buttons and making it work."

Many of the Soldiers conducting the training received a more in-depth experience on the equipment and operations than their previous experience at the Army Signal School.

"They don't get much hands-on (experience) in their advanced individual training, and they don't get the environment we are in out here, especially setting up the camouflage to disguise the equipment and being able to strategically place it so everything isn't in the way and your area is secure" Harmon said.

The Soldiers receiving the training echoed Harmon's sentiments about the utility of conducting the realistic training and how it will benefit them and their unit in

the future.

"I just hope we take away the knowledge we learn from each other to make better Soldiers of each one of us and make us accountable and safe setting up proper equipment," said 2nd Lt. Rucker Pierce, a platoon leader with 414th Signal Co., 3STB, 3IDSB. "Also to get repetitions in, so that when we go out for future field missions instead of supporting just a company we can better support the rest of the division and other units."

TRICARE For Life webinar held

Do you have questions about TRICARE For Life? Not sure if you're eligible for TFL, or how TFL coverage works? Join the "What is TRICARE For Life?" webinar on Feb. 27, from 1 to 2 p.m. Eastern Time to get your TFL questions answered.

The webinar will discuss TFL eligibility, when to sign up for Medicare, how to get care, and much more. Anne Breslin, the TRICARE For Life program manager at the Defense Health Agency and webinar presenter, will provide detailed information about TFL. Breslin will lead a Q&A after the presentation.

TFL is Medicare-wraparound coverage for TRICARE beneficiaries who are entitled to Medicare Part A and have Medicare Part B. Once you're entitled to Medicare Part A, have Part B, and show as eligible in the Defense Enrollment Eligibility Reporting System, you automatically receive TRICARE benefits under TFL.

"To make sure you don't have a break in your TRICARE coverage, it's important to keep your information up to date in DEERS," said Breslin. "You should also sign up for Medicare when you're first eligible to do so. Taking both of these steps will help

ensure that you get your TFL benefits on time."

As described in the TRICARE and Medicare Turning Age 65 Brochure, your birth date determines when you become Medicare-eligible based on age and when you should sign up for Medicare Part A and Part B. See examples below:

If your birthday falls after the first day of the month, you become eligible for Medicare on the first day of the month you turn age 65. You can sign up for Medicare between one and three months before the month you turn 65 years old.

If your birthday falls on the first day of the month, you become eligible for Medicare on the first day of the month before you turn age 65. You can sign up for Medicare between two and four months before the month you turn 65 years old.

But there are people under 65 years old who may become eligible for Medicare due to a disability. You must have certain disabilities or end-stage renal disease. Check out the TRICARE and Medicare Under Age 65 Brochure to learn more.

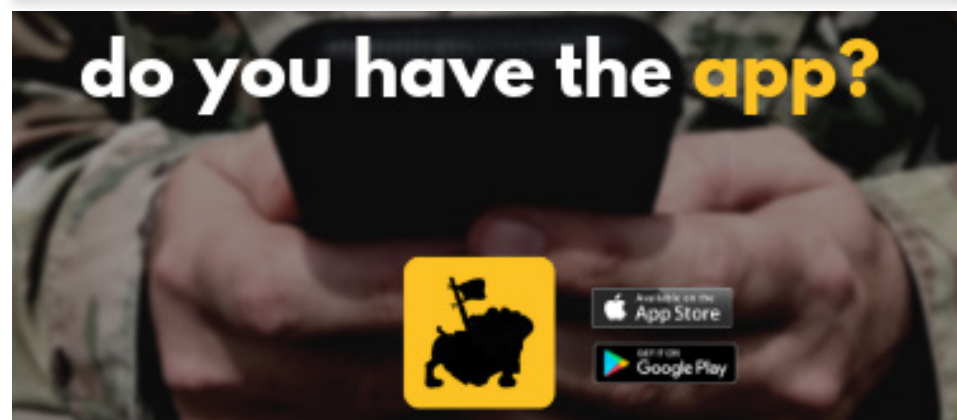

Expanded TRICARE Coverage for Ambulance Services

TRICARE expanded ambulance services to cover both treat-and-release and joint response services this year. TRICARE now covers:

Treat-and-release: This is when an ambulance treats you, but doesn't take you to the hospital.

Joint response: This is when an ambulance crew needs the help of a paramedic or intermediate EMT to give you advanced life-support services. Ambulances can be network or non-network providers. In an emergency, sometimes a non-network ambulance may treat or transport you. If a non-network provider bills you for treat-and-release or joint response, they can charge up to 115 percent of the TRICARE-allowable charge. Active-duty servicemembers aren't liable for payment for treat-and-release or joint response services. Learn more about TRICARE ambulance services and your costs. And take command of your health.

Army works to improve EFMP

FORT MEADE, Maryland — To improve assignment and case coordination for Families enrolled in the Exceptional Family Member Program, the Army's Human Resources Command has been developing a web-based system where support staff and families will be able to access cloud-based forms for faster processing.

Eventually the system will be able to link EFMP information with the Army's assignments process. It will also provide quicker access to EFMP data for Soldiers and their families.

Col. Steve Lewis, chief of the Army's Family Program Branch, G-9, calls it "stage 1" into making the system more efficient and accessible to EFMP families and plans to launch the system within the next year.

Lewis testified at a House Armed Services Committee hearing Feb. 5 where EFMP military Families voiced their concerns about difficulties in navigating the system and getting needed healthcare.

Additionally, during town hall meetings with EFMP Families in the past year, Lewis learned that some families have hardships when transferring healthcare and educational services from one installation to another during permanent-change-of-station moves.

"As children move from school district to another school district and across various states, we are finding the individualized education plans that were established at prior sites aren't always being adopted and acted upon the same way in the new installation," Lewis said.

The Army recently launched initiatives to improve the program, including establishing the Army's Quality of Life Task Force, where Lewis is deputy director.

"The individuals and teams established to support the Army's Exceptional Family Member Program share a unified purpose: to ensure a Soldier's assignment is fully capable of meeting the medical and educational needs of the Soldier's Family member," Lewis said during the Feb. 5 hearing.

Lewis said a key element in improving EFMP service will be communication. On Jan. 30, he attended a senior spouses' panel in Washington where he detailed the Army's long-term plans to improve services as well as listened to spouses' con-

cerns.

"We know we need to improve upon both the local marketing of the EFMP services from the Installation Management Command and connecting with Families and ensuring that they've got a very active web and social media presence," Lewis said.

The Army began its effort to revamp its EFMP process when then-Army Secretary Mark Esper ordered a comprehensive 13-question survey of more than 3,000 EFMP Families last May to identify "gaps and vulnerabilities" in the program.

The survey, developed by the Army Public Health Center at Aberdeen Proving Ground, Maryland, queried families on their experiences during PCS moves and hurdles in the process, said Dr. Jill Brown, public health scientist at APHC.

"The survey did allow us an opportunity to recognize that we do have challenges in reaching out and engaging and communicating with families to ensure that they know what Family support services are available," Lewis said.

The findings revealed that families could find primary care faster than special needs healthcare. The survey also showed Soldiers wanted greater flexibility in their re-assignments. In response, the Army's Human Resources Command at Fort Knox, Kentucky, has directed career managers to find a minimum of at least two assignment options with services accommodating to special needs Family members prior to issuing assignment instructions. This allows the families to conduct research on the locations and have a voice in the assignment process.

The Army currently has 119 full-time EFMP staff members to service 54,000 Families, including 55 system navigators that work within the Army Community Services offices. Lewis noted that the Army has an additional 80-90 staff members in the medical treatment facilities that include case coordinators. Within Child and Youth Services, school liaison officers help Families with special needs children address educational concerns.

"We know challenges remain and we have room to improve," Lewis said. "We must get this right."

Lewis said establishing the Quality of Life Task Force and the cloud-based data system will help the service achieve its broader people-based strategy.

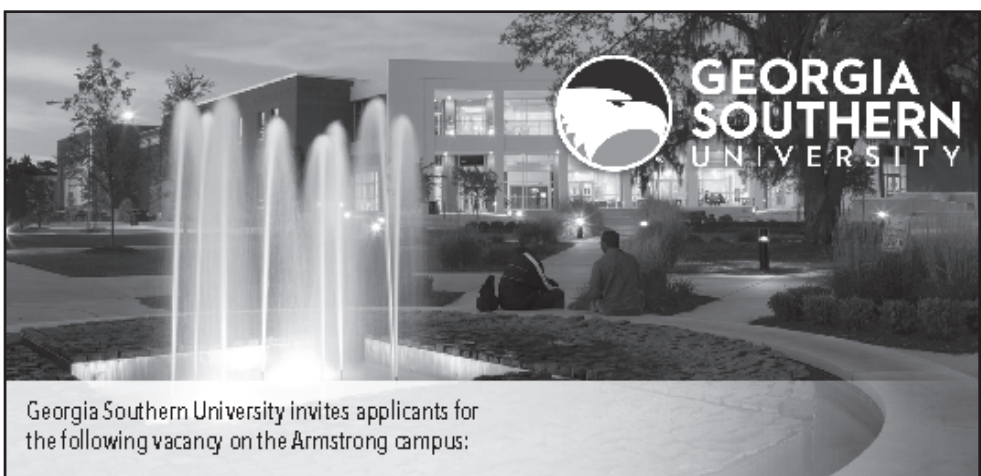

SFL-TAP transitions veteran to Marne team after service

The Fort Stewart-Hunter Army Airfield Soldier for Life-Transition Assistance Program offers several ways to help servicemembers as they consider the next step in their lives; whether continuing their military career, pursuing higher education, starting their own business or seeking employment.

Corbin Dantes-Perry recently transitioned out of the Army and chose to remain a part of the Marne Community as a federal employee. After graduating from DePaul University with a degree in information systems on an Army ROTC scholarship in 2011, he commissioned as a military intelligence officer. His Army career brought him to the Infantry Basic Officer Leader Course, Ranger School, Airborne School, Jumpmaster School and the MI Captains Career Course. He was stationed at numerous duty stations including Fort Benning, Fort Bragg and Fort Huachuca. He deployed to Iraq in support of Operation Inherent Resolve. His civilian transition goal was to continue federal service as he completed his master of public administration degree at Georgia Southern University.

Dantes-Perry's father, a senior executive service role for the Federal Deposit Insurance Corp in Washington, D.C., always promoted a federal civilian career. Dantes-Perry agreed.

"I wanted the stability and benefits that the Army provided without the constant moving," Dantes-Perry said.

He started applying to federal positions in the coastal Georgia area one year prior to his expiration of term of service as he understood that the process can take time.

"I would rather have to tell an agency that I can't start working because of my active-duty commitment over waiting last minute to apply," he said.

A back-up plan was to apply to private sector positions if he did not have a federal offer one month out from the start of his terminal leave.

Within the year, he applied to more than 30 positions through the job site USAJobs.gov. By casting a wide net and applying to various federal agencies,

grades and position types, he was able to increase his opportunities to achieve his goal. With the assistance from his father and the SFL-TAP Federal Resume Writing Workshop, he later received four referrals, was selected for one interview and was ultimately hired into a Department of the Army civilian position as a GS-9 at Fort Stewart.

Dantes-Perry started his new career as a range operations technician one week after signing out on terminal leave. "My timing was perfect for this transition. The position relates closely to my experience in the Army with the operations and leadership. "

The Directorate of Plans, Training, Mobilization and Security and Range Control has a lot of upward mobility and I plan on climbing as high as I can over the next 25 years at Fort Stewart," Dantes-Perry said. "I truly love this new career, supporting Soldiers' training, and working with veterans every day. Federal employment benefits are similar if not better than active duty, which is what I needed for my children," he said.

When asked for advice for other servicemembers going through SFL-TAP, he advised them to apply early and often.

"I always had at least 10 applications running at any given time," he said. "Every resume was tailored to each job announcement. Don't be picky. I was applying to GS-5 positions just to get in to the system. Submit a statement of service signed by your Commander in place of the DD214 while in the application process in order to apply to positions that are only available to Veterans. Don't give up. I was not referred or selected for 90% of the positions that I applied for and that was difficult for me to deal with at first. I know that I am competitive but also knew that that I was competing against other veterans, military spouses, current federal employees and people from all around the country."

The SFL-TAP team congratulates Corbin Dantes-Perry on his successful transition into federal employment.

92nd Engineers prepare for disaster response

The 92nd Engineer Battalion participated in a Defense Chemical, Biological, Radiological, and Nuclear Response Force four-day field training exercise on Fort Stewart, Feb. 10-13.

The exercise featured a simulated nuclear disaster response scenario that trained Soldiers of the 92nd in CBRN decontamination operations alongside civil authorities and first responder partner agencies.

“Our battalion worked in conjunction with Northern Command and Joint Task Force Civil Service to evaluate our units in preparation for any disaster that occurs within the United States,” said Capt. Bryan Wierson, a plans officer assigned to the 92nd Engineers.

This exercise featured an urban search and rescue team, a realistic decontamination venue, and many civilians who were contracted to role-play as real-world casualties.

“We had a mass casualty decontamination line where they received and assessed the casualties,” said Wierson. “The 51st CBRN Company, the 554th Engineering Construction Company, and the 36th Area Support Medical Company from Fort Bragg (North Carolina) worked as a team to facilitate the movement of the victims.”

Medics were staged at the decontamination site to train in treating the influx of casualties.

“We received training to be able to manage radiation and additional injuries we’d encounter involving mass casualties in a nuclear disaster,” said Sgt. Charles Bouchier, a health care specialist assigned to 36th ASMC.

“It was all about evacuating as many people as we could in the shortest amount of time and doing so effectively,” said Bouchier said.

In a real-life event, supporting agencies such as the Red Cross, Federal Emergency Management Agency, and other local and state entities would be involved, said Tom Phillips, a civilian contractor for L2 Defense, who also acted as an incident commander for the exercise.

Phillips said the 92nd Engineers supports the Dept. of Defense’s DCRF mission, and the unit has the capability that is required for a mass casualty event

“They bring a very robust response with a very robust capability,” said Phillips.

The value of the four-day exercise was realized among participants.

“We’ve seen accidents in the past where CBRN events devastated the local population,” said Bouchier, “which made this training very important to medics, because we must be able to treat various injuries in the event a nuclear disaster.”

Pfc. Cassandra Brown, a horizontal construction engineer assigned to 554th Engineering Construction Company said they learned how the DCRF was operated so if their assistance was needed, they would be proficient.

The exercise scenario tested Soldiers of the 92nd Engineers on how to conduct decontamination operations during an unpredictable

timeline of events.

“The battalion increased capability and confidence with each passing day,” said Wierson said. “They were resilient in the midst of the constant changes and remained flexible and adaptive in overcoming those changes throughout the exercise.”

This training exercise was conducted in preparation for the culminating event Guardian Response, which is scheduled for late April.
