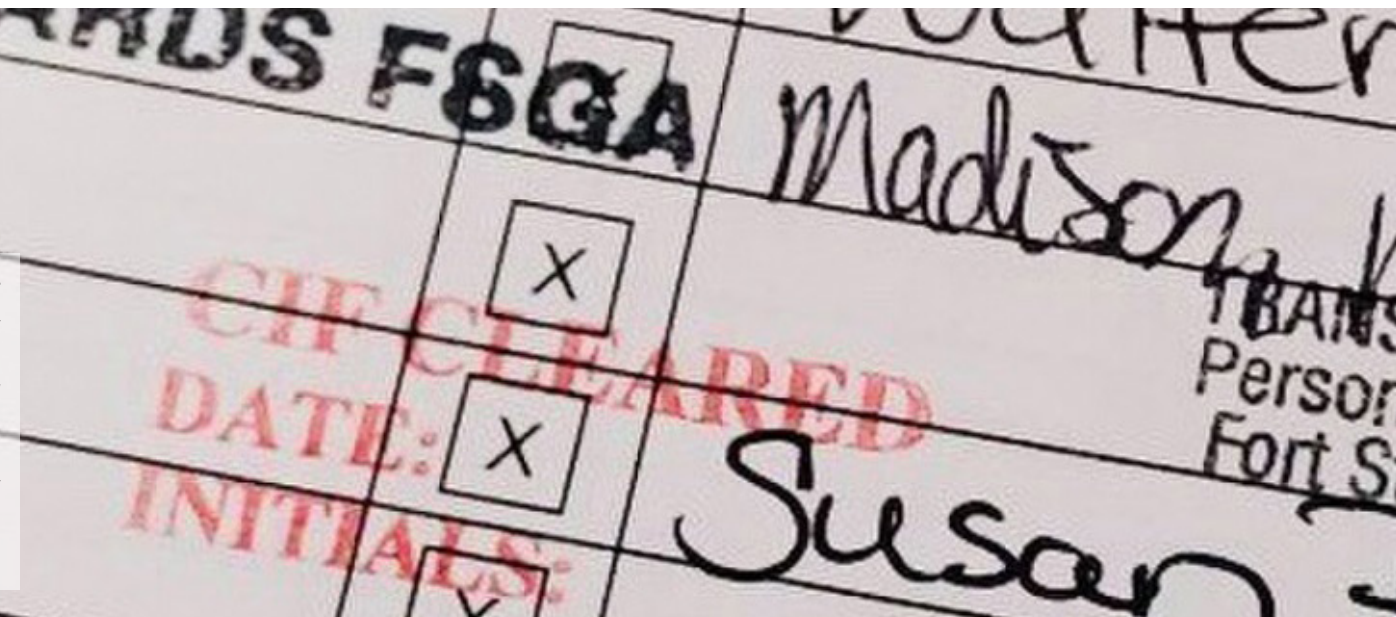

CIF modernizes with online appointments, less turn-ins

The Soldiers of Fort Stewart-Hunter Army Airfield will have a different experience at their Central Issue Facilities, as they are transforming to make the issuing process easier for the warfighter.

Transitioning to appointments

Soldiers are now able to schedule appointments online for their CIF turn-in and exchanges, as the facilities are transitioning to modern storefront programs.

“After a few weeks of testing the system with the Marne Reception Center, the appointment system is now live,” said Lt. Col. Chad Moniz, the battalion commander of the 406th Army Field Support Battalion-Stewart, who is responsible for the Fort Stewart and Hunter Army Airfield CIFs. “The system will enable a better experience for the Soldier, while maintaining a forecastable schedule for the CIF staff that still needs to be ready to respond to real-world surge requirements,” he said.

Appointments will be made in 15-minute increments but the AFSBn team recommends Soldiers arrive 10 minutes early to allow for accountability. The system is set up to accommodate eight people every 15 minutes.

For now, the new program has focused times targeting different needs. Soldiers from the Marne Reception Center will be accommodated daily until 10:00 a.m. From 10:00 a.m. to 2:30 p.m., CIF has open appointments for any service. From 2:30 -3:30 p.m., the CIF will continue to have walk-in open time to enable Soldiers that do not have appointments or who may not have access to common access card-enabled computers to make the appointments. Appointments can be made up to two weeks prior to the requested date.

Moniz explained that the appointment program will send Soldiers an email once the appointment is booked.

It will also notify the CIF of what services Soldiers are requesting, whether it is for exchanging equipment, receiving new issue, or turning in old equipment.

Overhauls to adjust to transformation

While the modernization will result in welcomed improvements, the transition caused some delays for CIF customers in August and September.

Nia Landry, deputy commander of the 406th AFSBn, said that an accountable officer unexpectedly retired during the key implementation of several phases of the modernization process, forcing the CIF to conduct a 100% accountability inventory of both sites. This, combined with a large surge of Soldiers with PCS orders, caused backups in the system.

“It was not our intent in any way to inconvenience Soldiers and their families,” Landry said. “Moving forward, we have several things in place that will improve your experience at CIF, and we always welcome suggestions as we strive to get better.”

Throughout the inventories, the average throughput did not decrease. The facility on average services 100 Soldiers in the morning, and 100 in the afternoon. As a result of an uptick in approved PCS orders following a long pause with COVID-19, the Fort Stewart and HAAF facilities surged to support more than 300 customers a day.

The two CIFs support missions for not only the 3rd Infantry Division, but also a Ranger battalion, and other unique tenant units across both installations. They will continue to reduce stock by another half over the next few months as they send items to locations as directed by disposition instructions.

“We were sacrificing the time now to better support Soldiers later by improving our processes,” said Kevin Lewis, the supply and services division chief for the CIF facilities.

He explained tenant units like those in Special Forces will eventually go to systems managed by their supply sergeants to do more direct ordering. This process will solve more problems at the unit level and save Soldiers a trip across the base while also reducing strain on CIF.

Soldiers can also expect to get more of their equipment issued by their own supply rooms as fewer items are kept on hand at CIF. The facility will still handle exchanges and turn-ins. However, if units are exchanging something that is not typically stocked in the facility, it will have to be ordered.

Planning for future CIF visits, PCS moves

As thousands of 3rd ID Soldiers redeploy from Europe and South Korea in 2021 along with traditional PCS moves, it's important to relearn what most career Soldiers already know: always try to clear CIF first.

While the experiences this summer were unprecedented, it was a good reminder for Soldiers to leave extra time in their clearing process for CIF in case they are missing items or if their equipment needs further cleaning.

“The best way to be prepared for CIF is to check your online Organizational Clothing and Individual Equipment record,” Moniz said. This will tell you exactly which items you can carry with you, and which ones need to be turned in.”

“For Soldiers at Fort Stewart and Hunter Army Airfield who are in a PCS status, from now on most will only turn-in their [Enhanced Small Arms Protective Inserts] plates,” he said. They can carry forward their OCIE gear with their household goods through the transportation personal property office.”

While the appointment system is now open, clearing papers and orders are still required for service. To make an appointment, click on the link labeled “CIF appointment” in the bottom left corner of the individual's OCIE clothing record.

The Flu vaccine is covered by TRICARE with no cost-shares or copayments if it's administered by a pharmacist at a participating network pharmacy or by a TRICARE-authorized provider. Remember to keep a copy of your vaccination record. A copayment or cost-shares will apply if given within outpatient office visit, though the vaccine is free. 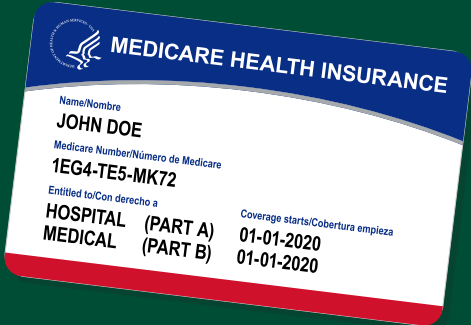

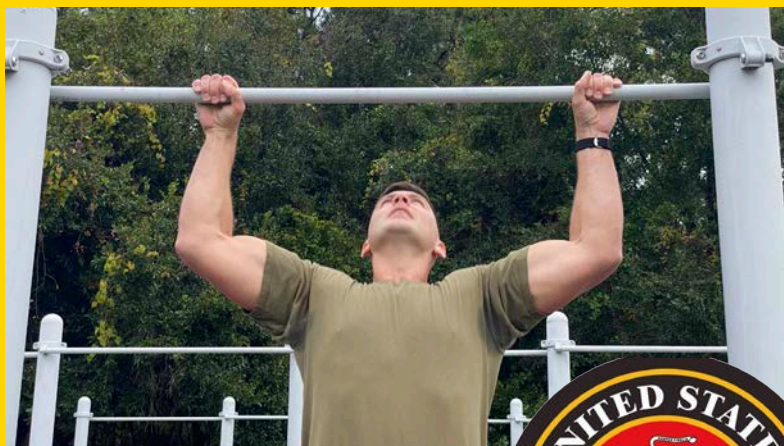

RAIDERS TAKE ON KOREA

CAMP HOVEY, SOUTH KOREA—The 1st Armored Brigade Combat Team, 3rd Infantry Division, assumed responsibility as the rotational armored brigade combat team in Korea Nov. 12 during a transfer of authority ceremony.

Soldiers from the Raider Brigade began arriving to Korea in October to begin their nine-month rotation. Raider Soldiers replaced the Soldiers of the 2nd Armored Brigade Combat Team “Dagger,” 1st Infantry Division out of Fort Riley, Kansas.

The day presented a unique occasion; representatives of the three longest-serving divisions took the field together. The 1st, 2nd, and 3rd Infantry Divisions are all historical divisions that have fought and served together for more than one-hundred years.

The TOA ceremony was the final step in the month-long transition between the two brigades and was hosted by Maj. Gen. Steve Gilland, 2nd Infantry Division and Republic of Korea-U.S. Combined Division commander.

“As we say farewell to the Dagger Brigade, we welcome the Raider Brigade,” Gilland said. “Raider [Brigade] is back for the second time in five years.”

This is the second time that Soldiers bearing the 3rd ID patch have served as a rotational unit in the Republic of Korea since fighting throughout the Korean War.

“Their second time in the Korean theater of operations is pretty significant and I look forward to seeing them in action,” Gilland said.

During the war, 3rd ID had 13 Medal of Honor recipients, received eight Battle Stars and were awarded The Republic of Korea Presidential Unit Citation. The 7th Infantry Regiment of 3rd ID recorded more combat time than any other infantry unit in Korea.

“Today’s ceremony signifies the transition of the Raider Brigade from our mission preparation actions over the last year plus, to embarking on our mission to deter aggression and maintain peace on the Korean Peninsula,” said Col. Trent Upton, 1ABCT, 3rd ID commander. “Today’s ceremony also carries a special significance for me. It seems like yesterday when 2nd Lt. Upton started his career, right here at Camp Hovey, in a place that feels much like home.”

The Raider Brigade has a storied history including four deployments to Iraq and most recently a deployment to Europe in 2015 as part of Operation Atlantic Resolve. While this is not a new mission for the Raider Brigade and 3rd ID, it is the Army’s ninth such rotation to the Republic of Korea. The rotations began in 2015 after the 2nd Infantry Division’s last organic combat brigade, the Iron Brigade, was deactivated.

“The uniform we wear, be it our own or those of our ROK teammates, represents two things: first, it represents the combined resolve of our alliance; second, it represents hope for peace, as we go together,” Upton said.

Controlled burn season to begin on Fort Stewart

The Fort Stewart-Hunter Army Airfield Forestry Branch will begin a controlled burn season on December 1, 2020, that will continue until June 30, 2021. Controlled burning is a managed burn that uses low intensity fire to improve and enhance our Soldiers' training lands, reduce wildfire hazards and improve wildlife habitat. Without regular fire, the forest floor becomes dense with small trees and shrubs - known as underbrush - which serve as fuel for wildfires. Areas of dense underbrush cause wildfires to burn hotter, larger, longer and faster - making them more difficult and dangerous to manage. Controlled burns provide the benefits that regular fires historically provided to an environment, while also preventing the fires from burning out of control and threatening life and property. As a result of Fort Stewart's aggressive burn program, the number of wildfires has steadily decreased over the past decade. Since the year 2000, not one day of training has been lost on the Installation due to wildfires.

Extensive preparation and work goes into each planned burn. The Forestry Branch develops burn prescriptions for each area that will be burned during the season. These planned burns may involve burning 500 acres to 2,500 acres per day and may occur on any day during the burn season. Even with preplanning, the dates of each burn

are only estimates as they are dependent upon weather conditions as well as access to military training areas. However, the Forestry Branch goes to great lengths to ensure the Installation and surrounding communities are aware of scheduled burns and are up-to-date on any

changes to the burn plan for a particular day.

During a burn, Forestry monitors weather via the National Weather Service in Charleston, the Georgia Forestry Commission, from five local Remote Access Weather Stations located throughout Fort Stewart and close observation from at least two of the five fire towers located on the Installation. Fort Stewart and Hunter Army Airfield foresters do everything within their power to manage smoke impacts from these burns and ensure the safety of residents both in and around the installation. However, there are uncontrollable conditions, such as sudden changes in wind direction or intensity that can cause smoke to drift into surrounding neighborhoods or highways. For this reason, the Forestry Branch asks residents to be aware of the ongoing burn season and to use extra caution when traveling through areas where smoke may be present.

Fort Stewart-Hunter Army Airfield recognizes that our forests and trees are a vital resource to both our present and future missions. Controlled burning is critical to sustaining the environment in which we train, work, live and play as well as preserving it for future generations.

New monthly premiums for TRICARE Young Adult plans

Beginning on Jan. 1, premiums for TRICARE Young Adult coverage will increase. TYA Select will increase by 12.7% and TYA Prime by 22%. These changes reflect the increase in TYA program costs for calendar year 2021.

TYA is a premium-based plan available for purchase by qualified dependent children under the age of 26. Young adults who are 21 - or age 23 if a fulltime student - lose regular TRICARE coverage, but may be eligible to purchase TYA coverage.

If you're a sponsor or TYA enrollee, here's what you need to know:

- TYA Select premiums increased from \$228 to \$257 per month.

- TYA Prime premiums increased from \$376 to \$459 per month.

These increases go into effect next year. If you want to switch between TYA Prime and TYA Select, you can do so at any time. Your sponsor's status and your geographic location determine whether you can purchase either TYA Prime or TYA Select. Be sure to contact your TRICARE contractor if you have questions.

TRICARE understands the impact these changes may have on TYA enrollees and their sponsors. Adult-age, dependent chil-

dren are encouraged to evaluate all health care coverage options after aging out of TRICARE.

While you may qualify to purchase TYA coverage, it may not be your only health care coverage option. You may want to explore other health plan options available through the Health Insurance Marketplace before purchasing TYA coverage. Visit healthcare.gov to learn more.

Provider Quartermasters keep Marne Air ready

As an AH-64 Apache flares in for a landing returning from engaging targets during aerial gunnery, Soldiers running a Forward Arming and Refueling Point rush into action to prepare it to continue its mission. Ammunition is loaded and the aircraft checked for readiness. Fuel is loaded onto the aircraft and the pilot spins up the rotors and lifts off for another engagement.

To keep these aircraft in the sky, the Soldiers from the 135th Quartermaster Company, 87th Combat Sustainment Support Battalion, 3rd Infantry Division Sustainment Brigade, are delivering more than 4,000 gallons of bulk fuel to the 3rd Battalion, 17th Cavalry Regiment, 3rd Combat Aviation Brigade, 3rd Inf. Div.

The 135th QM Co. serves as a bulk petroleum, oil and lubricant distributor for the division ensuring that the units assigned to the division are prepared to conduct their missions by enhancing their lethality and maintaining their role as the Army's premiere armored divi-

sion.

"135th QM CO currently has a unique mission in support of 3rd Inf. Div. Bulk Fuel and Fuel Quality Surveillance operations," said Chief Warrant Officer 2 Shanique T. Clarke, assigned to Headquarters and Headquarters Company, Special Troops Battalion, 3rd Inf. Div. Sust. Bde. "Daily 135th QM Co. provides Fuel Quality Surveillance testing in support of monthly required Filter Effectiveness Test samples that are submitted by 3rd Inf. Div. units assigned to Hunter Army Airfield, Fort Stewart and Fort Benning."

The mission to support 3rd CAB was conducted from Oct. 25 to Nov. 5 at a remote field site simulating the CAB operating in an austere environment.

"What makes issuing fuel to a FARP unique is the fact that sometimes Soldiers go their entire careers and are never afforded the opportunity to conduct aviation operations as a petroleum supply specialist," said Chief Warrant Officer 1 Omar J. Stoddard assigned to 135th QM Co.

To conduct their mission the petroleum supply spe-

cialists had to not only deliver fuel, but go through a more rigorous process to ensure it was up to aviation standards.

"The mission was not difficult yet we faced challenges due to our equipment not being constantly used during the pandemic timeframe," said Spc. Justin Toadvine assigned to 135th QM Co.

This type of mission reinforces training that 135th usually does not participate in unless they are overseas where their platoons regularly deliver fuel to units including the CAB both at home station and while deployed.

"In Honduras the platoon element conducts sling load and aviation orientated missions which our company does not normally get involved in," said Toadvine. "Doing missions such as this brings us into the world of aviation again and puts us in the mindset to utilize information we haven't accessed as often."

As this mission supporting aerial gunnery ends the 135th continues to prepare to support and sustain the division on the ground or in the sky.

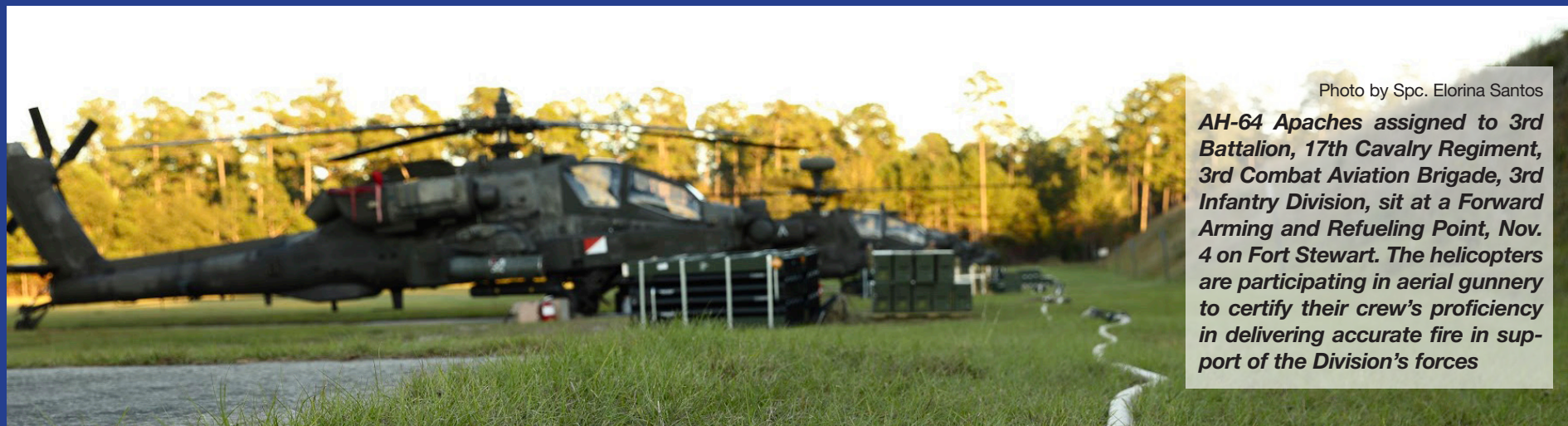
