

# HSM-70.2 Returns From Deployment

### From HSM-70 Public Affairs

Last June, the Helicopter Maritime Strike Squadron (HSM) 70.2 “Airdogs” said goodbye to their loved ones as they departed from Jacksonville to Norfolk, Virginia to embark USS Winston S. Churchill (DDG-81) for their work-ups and a deployment.

After concluding training events, the squadron became integrated into the ship’s crew. During ship exercises, the Airdogs launched an emergency medical evacuation from the ship to transport a Sailor to Camp Lejeune Naval Hospital.

The Airdogs officially started their deployment Aug. 10, 2020. On their way to

5th Fleet area of responsibility (AOR), they made a brief stop in 6th Fleet AOR for a Greek Anti-Submarine Warfare Exercise event and PhotoEx with the Tunisian Navy.

The HSM-70.2 Airdogs played an integral role in 5th Fleet’s mission completing 14 Bab-el-Mandeb and eight Strait of Hormuz transits escorting merchant vessels safely through the areas.

On Oct. 12, the ship and crew participated in the USS Cole (DDG-67) Remembrance ceremony. USS Cole was bombed by terrorists on Oct. 21, 2000 while refueling in Yemen, killing 17 Sailors.

In early 2021, working with the U.S. Coast Guard Advance Interdiction Team, the

**Schmidt was part of the HSM-70.2 “Airdogs” 9-month deployment to 5th and 6th Fleets.**

Airdogs participated in Operation Nexus Guard. On one mission, squadron personnel provided intelligence, surveillance and reconnaissance overwatch for 23.1 continuous hours, ensuring the success of the mission. In February, the detachment provided overwatch for the successful boarding of two suspect dhows. They provided coverage for 43.6 hours allowing the recovery of over 3,000 AKM weapons and thousands of various machine guns, rifles, and RPGs.

The squadron returned home to NAS Jacksonville, March 18-19 with families and friends waiting at the flight lines.

Eighty-three nominations were submitted to compete within the 14 categories for this year’s Navy F&ES Awards.

“Just to be considered as a candidate for DOD Firefighter of Year is truly an honor,” said Adam Moriarity, Navy Civilian Firefighter of the Year. “I know each of the individuals that I am up against went above and beyond the call during this past year. Being selected in each of these levels is something I will never forget for the rest of my life. Without this amazing group of firefighters I get to work with and the supervisors that mentor us daily I would not be where I am.”

The Navy F&ES Hall of Fame was established in 2003 to recognize significant and distinguished contributions to the Navy firefighting services.

The Navy F&ES Lifetime Achievement Award honors individuals who have been firefighters for at least 20 years, to include 10 years of service to Navy F&ES, and whose remarkable achievements in the fire service exemplify outstanding performance.

Category criteria was developed by the Department of Defense F&ES working group comprised of the chiefs of the service component’s respective F&ES programs.

Selections for fire departments and fire prevention program of the year awards were based on: emergency response performance; department level recognition, accreditation and certifications; customer outreach and public education; training and education; innovation and initiatives in safety, health and quality of life; fire prevention inspections, engineering, code compliance and enforcement; community and public education programs; and innovativeness.

Selections for individual categories were based on accomplishments, job performance, technical competence, leadership ability, initiative, resourcefulness, program development, training development, performance as an instructor, trainer or speaker and professional credentials.

The Navy F&ES Awards Program was instituted in 1997 to recognize the most outstanding fire departments and personnel for achieving the highest degree of excellence in mission support and fire protection management.

CNIC is comprised of approximately 52,000 military and civilian personnel worldwide responsible for the operations, maintenance and quality of life programs to support the Navy’s fleet, Sailors and their families.

# VP-30 Among Five Squadrons Earning Cmdr. Theodore G. Ellyson Aviator Production Excellence Awards

Chief of Naval Air Training (CNATRA) recognized the accomplishments of five naval aviation squadrons, March 24, honoring them with the fiscal year 2020 Cmdr. Theodore G. Ellyson Production Excellence Awards.

CNATRA Rear Adm. Robert Westendorff presented the awards during CNATRA’s Production Alignment Conference in San Antonio.

Awardees are: Primary squadron – the “Boomers” of Training Squadron (VT) 27 based at Naval Air Station (NAS) Corpus Christi; advanced squadron – the “Sabrehawks” of VT-86 based at NAS Pensacola, Florida; Commander, Naval Air Force Atlantic – the “Pro’s Nest” of Patrol Squadron (VP) 30 based at NAS Jacksonville, Florida; Commander, Naval Air Force Pacific – the “Se-

ahawks” of Helicopter Maritime Strike Squadron (HSM) 41 based at NAS North Island, San Diego; and U.S. Marine Corps – the KC-130J fleet replacement detachment based at Marine Corps Air Station Cherry Point, North Carolina.

The Ellyson awards program is one of three Chief of Naval Operations aviation-related award programs. It examines squadrons’ efficiency, ability to meet fleet requirements for production, time to train, and mitigation strategies to combat external resource or execution barriers if present.

All Navy and Marine Corps fleet replacement squadrons, Marine aviation training units, and all CNATRA training squadrons are eligible for the awards. Each winning squadron received a plaque to commemorate the achievement.

The awards are named for Cmdr. Theodore G. Ellyson, the first naval

officer to undergo aviation training and designated naval aviator #1 in 1914. Ellyson was instrumental in the development of all facets of naval aviation including the establishment of the first flight training sites, which were termed naval aviation camps, in Annapolis, Maryland, and San Diego.

“Training and developing our students to be the best aviation profes-

sionals in the world is critical to the security of our nation,” Westendorff said. “We rely on the dedicated men and women of our training squadrons and fleet replacement squadrons to meet fleet aviation manning requirements. Today we recognize these five squadrons for their production efficiency in FY-20.”

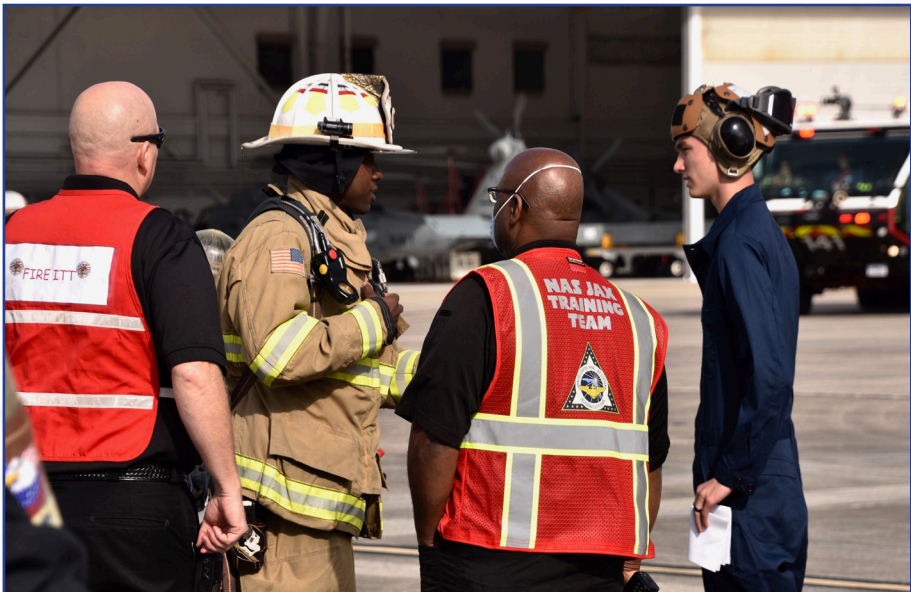

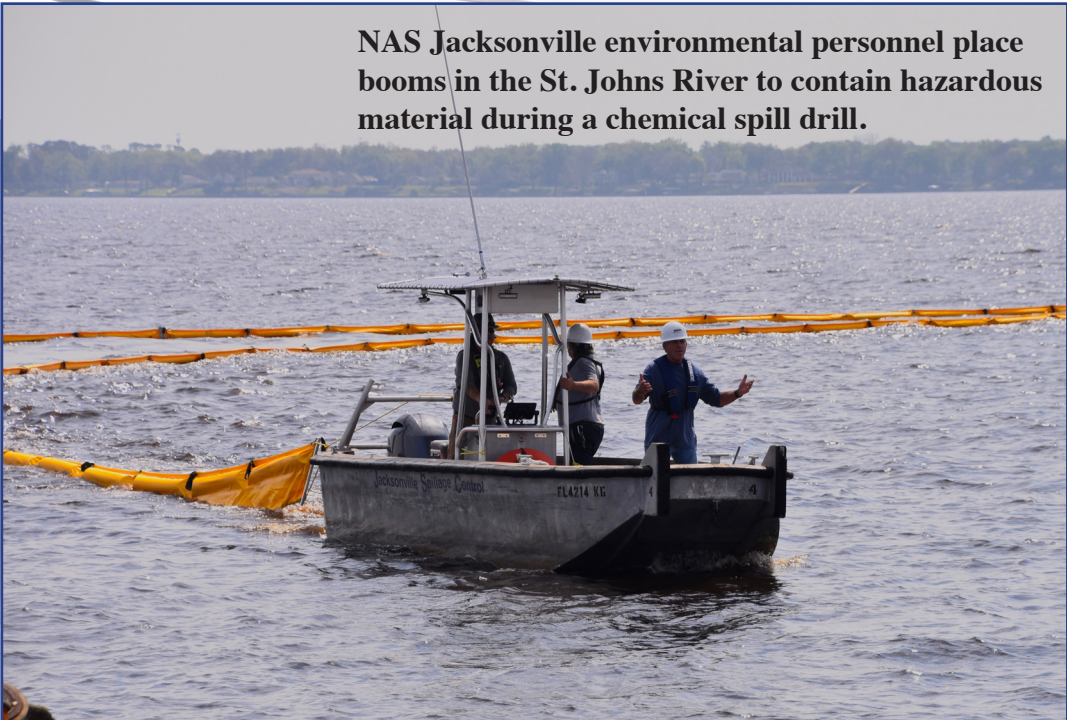

# Tax Day for Individuals Extended to May 17: Treasury, IRS Extend Filing and Payment Deadline

The Treasury Department and Internal Revenue Service have announced that the federal income tax filing due date for individuals for the 2020 tax year will be automatically extended from April 15, 2021, to May 17, 2021.

“This continues to be a tough time for many people, and the IRS wants to continue to do everything possible to help taxpayers navigate the unusual circumstances related to the pandemic, while also working on important tax administration responsibilities,” said IRS Commissioner Chuck Rettig. “Even with the new deadline, we urge taxpayers to consider filing as soon as possible, especially those who are owed refunds. Filing electronically with direct deposit is the quickest way to get refunds, and it can help some taxpayers more quickly receive any remaining stimulus payments they may be entitled to.”

Individual taxpayers can also postpone federal income tax payments for the 2020 tax year due on April 15, 2021, to May 17, 2021, without penalties and interest, regardless of the amount owed. This postponement applies to individual taxpayers, including individuals who pay self-employment tax. Penalties, interest and additions to tax will begin to accrue on any remaining unpaid balances as of May 17, 2021. Individual taxpayers will automatically avoid interest and penalties on the taxes paid by May 17.

Individual taxpayers do not need to file any forms or call the IRS to qualify for this automatic federal tax filing and payment relief. Individual taxpayers who need additional time to file beyond the May 17 deadline can request a filing extension until Oct. 15 by filing Form 4868 through their tax professional, tax software or using the Free File link on IRS.gov. Filing Form 4868 gives taxpayers until October 15 to file their 2020 tax return but does not grant an extension of time to pay taxes due. Taxpayers should pay their federal income tax due by May 17, 2021, to avoid interest and penalties.

The IRS urges taxpayers who are due a refund to file as soon as possible. Most tax refunds associated with e-filed returns are issued within 21 days.

This relief does not apply to estimated tax payments that are due on April 15, 2021. These payments are still due on April 15. Taxes must be paid as taxpayers earn or receive income during the year, either through withholding or estimated tax payments. In general, estimated tax payments are made quarterly to the IRS by people whose income isn’t subject to income tax withholding, including self-employment income, interest, dividends, alimony or rental income. Most taxpayers automatically have their taxes withheld from their paychecks and submitted to the IRS by their employer.

## Free tax service for military families

The United Way RealSense volunteer tax preparers will not work at Naval Air Station Jacksonville due to COVID restrictions. However, they will offer free tax service at the VyStar Credit Union office building located at 4949 Blanding Boulevard, Jacksonville starting Feb. 12 through tax season. They will be open Monday through Friday from 9 a.m. to 3 p.m. however, they are not offering sit-down tax preparation.

Clients must make an appointment by calling the United Way at 211 or going online to <https://unitedwaynefl.org/.../realsense/free-tax-filing/>. They will be given a date/time to go drop off their paperwork, and a volunteer will ensure the paperwork is in order. A tax preparer will then complete the tax documents and clients will receive a phone call to go back and sign the documents. They will then be submitted to the Internal Revenue Service.

May 17, 2021, only applies to individual federal income returns and tax (including tax on self-employment income) payments otherwise due April 15, 2021, not state tax payments or deposits or payments of any other type of federal tax. Taxpayers also will need to file income tax returns in 42 states plus the District of Columbia. State filing and payment deadlines vary and are not always the same as the federal filing deadline. The IRS urges taxpayers to check with their state tax agencies for those details.

## CIWT-Managed Foreign Language Testing Sites Reopen for Business

**From the Center for Information Warfare Training's Language, Regional Expertise, and Culture Team**

The Center for Information Warfare Training-managed foreign language testing sites in Everett, Jacksonville, Norfolk, Pensacola, and San Diego will resume foreign language testing services at a reduced capacity in compliance with the Centers for Disease Control and Prevention and Department of Defense (DoD) COVID-19 mitigation policies, April 2021.

Sites will administer the Defense Language Aptitude Battery (DLAB) and Defense Language Proficiency Tests (DLPT) by appointment only, so testing will not be available on a walk-in basis.

Personnel may schedule an appointment to take a DLAB or DLPT by visiting the following portal: <https://www.mnp.navy.mil/group/training-education-qualifications/appointment-scheduler>

Test control officers (TCO) will manage site testing schedules and prioritize testing as necessary. If you have an urgent, mission-driven need to complete a test (e.g., to certify foreign language proficiency for a pending assignment to a billet coded for foreign language skills), but cannot identify an open appointment slot using the scheduler link, please contact the site TCO directly for assistance using the following

On testing days, TCOs will screen all examinees in accordance with current Commander, U.S. States Fleet Forces Command/ U.S. Naval Forces Northern Command guidance and may deny entry to the testing facility based on unfavorable screening results (e.g., elevated body temperature).

While in the testing facility all personnel are required to wear DoD-approved personal protective equipment properly (i.e., mask covering nose and mouth) and maintain six feet of separation from others at all times.

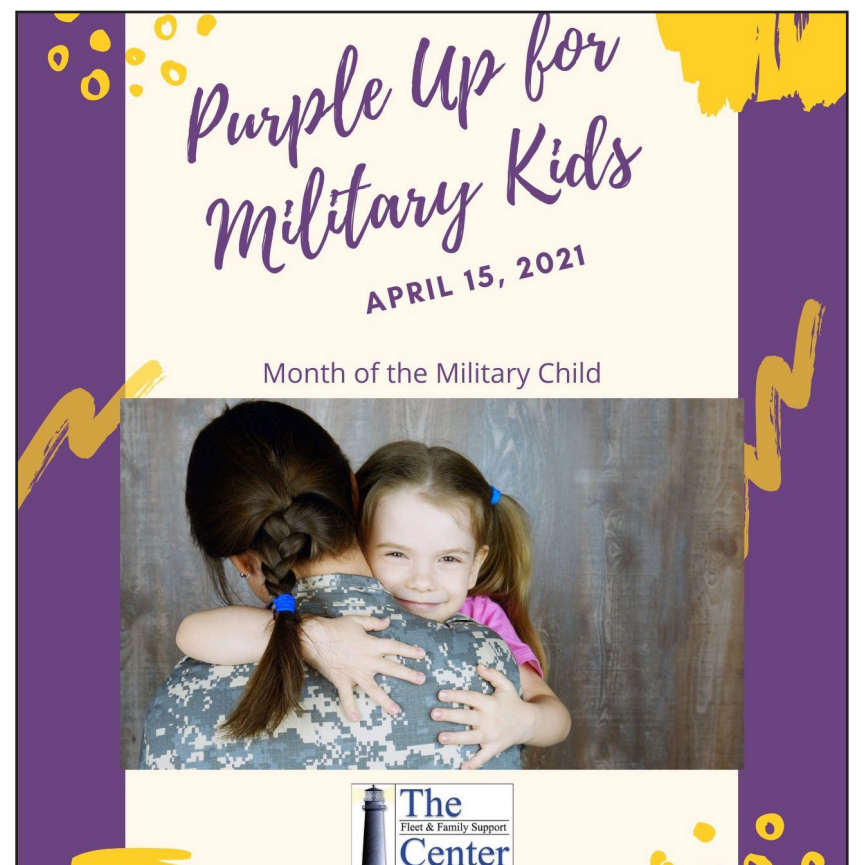
