Extend Dimes Drive--\$34,000 In Till

The Camp Lejeune March of Dimes campaign pyramids into its last week of fund raising today, with hopes running high that the 1951 grand total of \$41,000 will be topped by this year's whirl-wind drive.

Sparked by polio-conscious Leatherneck units who are vying for

top contribution honors, the March thus far has raised \$34,726.30. With the campaign extended an extra week to February 7, drive officials are hopeful that overall donations will go well past the \$40,000 mark.

As the red-hot race for contribution laurels moved into the home stretch, M.P. Company of the Sec-

ond Division swooped into top spot with a total contribution of \$437, an average of \$3.65 per man.

The MP's took over the lead from H & S Co., Supply School Bn, at Montford Point which last week paced the field with \$3.45-per-man average donation.

Monday afternoon, Prima took his boys and Keely over to the Naval Hospital and put on a show for the men there. Perambulatory patients were taken to the hospital auditorium for a full show. Then

Prima took a five man combo to all bed-patient wards for some impromptu skits, and a short jam session.

Members of the orchestra stayed on the base, eating their meals at the Camp Hostess House and sleeping in quarters at the Camp Theatre.

Special Services has announced that more shows of a like type are being considered for future dates, and so far the Ted Weems Orchestra has been booked for next month.

Former Underground News Boy' Now Marine Mailman

The distance between Kaunas, Lithuania and Brooklyn, U. S. A., is covered in only 30 hours by air, but for Marine Pfc. Algirdas Reventas it took nine long years.

Five of these years were spent escaping the clutches of the Nazis and Communists, before being liberated by the British. Then he waited four years for a visa, before arriving in the United States.

Reventas, a native of Lithuania, considers himself very lucky because he, his parents, and two brothers were able to survive five years of war and make it to "The

Land of Opportunity" through the International Refugee Organization. He was drafted in the Marine Corps in September, 1951.

The Lithuanian Leatherneck was a boy of 12 when the Russians first invaded his country in 1940. His father was the manager of a dairy which exported products to England.

A year later the Germans invaded Lithuania and drove out the Russians. "From a list of Russians left behind, we discovered that my father was one of 60,000 businessmen, priests, teachers and army officers marked for shipment to Siberia," related Reventas.

"Our country was completely disrupted," he emphasized. "There were four undergrounds; the Lithuanian, Polish, German, and Russian. No one could be trusted."

The underground hid boys who were to be sent to fight for Germany he continued. "It was my job to distribute the underground newspapers."

"The price was high for sabotage," he added. "If the saboteurs weren't found, the Germans went to dances and other affairs."

Six officers of the Tenth Marines were graduated last week from the first artillery air observers school ever held at Camp Lejeune.

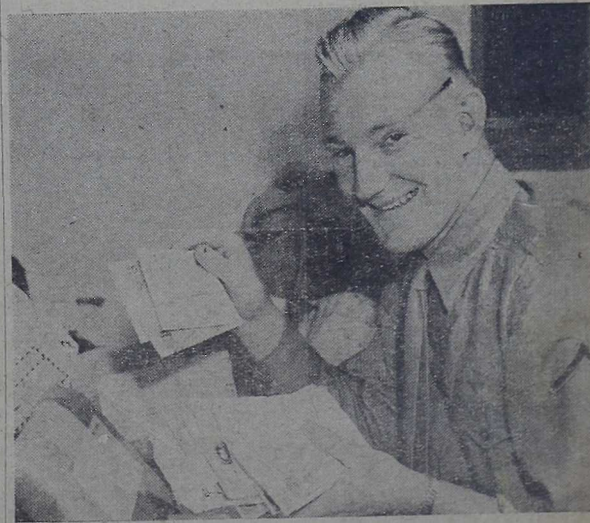
The school, specially designed to train officers in the art of air reconnaissance and spotting for tactical ground units, ended last week after four weeks of intensive training in such subjects as tactical and gunnery air observation, photography and mapping, intelligence and communications.

Under the direction of Capt. Harry L. Sherwood, Senior Air Observer, and Capt. Henry E. Centner, assistant, the school included 40 to 50 hours of flying time for the six officer-students from VMO-1, the observation squadron attached to the Second Marine Division and based at the Peterfield Point Air Station.

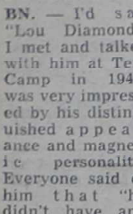
Who Was The Most Unforgettable Marine You Ever Met?

CWO THOMAS J. CONNELLY, DISBURSING OFFICE, SUP. SCH. BN. — I'd say



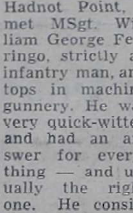

1ST LT. GEORGE E. MC ALEE, SUP. SCH. BN.—In 1949 while at



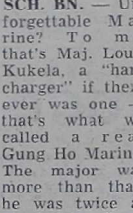

CWO JAMES H. HARRINGTON, PERSONNEL OFFICER, SUP. SCH. BN. — Un-



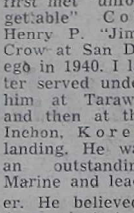

CWO KENNETH J. (MIKE) FAGAN, MOTOR TRANSPORT SCHOOL. — I



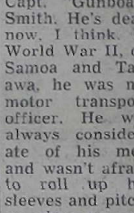

Test New Jackets

Fourteen thousand new-type armored vest-jackets, made of laminated nylon and weighing only eight pounds, will be tested by combat troops in Korea starting next month.

Developed by the Army Quartermaster Corps, the jacket resists a .45-caliber pistol bullet at point-blank range, stops most all fragments from a grenade bursting at a distance of three feet, and 75 percent of the fragments from a mortar burst at a distance of ten feet.

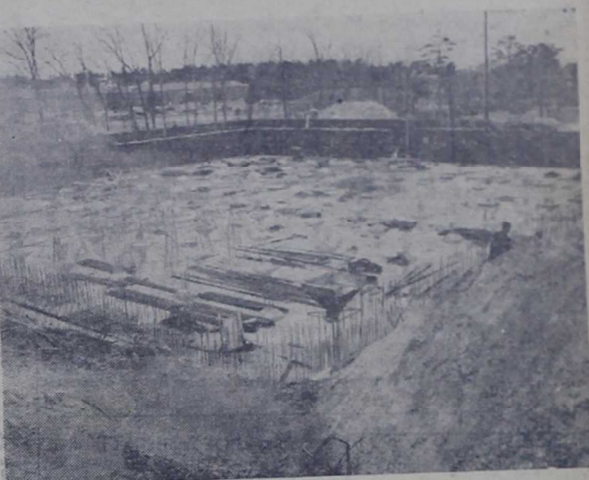
Frustrated Red

Chosin Breakout Chief Given DSM

"For exceptionally meritorious service" as First Marine Division commander in Korea, Maj. Gen. Oliver P. Smith, now Camp Pendleton Commanding General, was recently presented the Distinguished Service Medal by Maj. Gen. William B. Kean, Third Army Corps Commander and former chief of the Twenty-fifth Infantry Division during Korean action.

A veteran of more than 34 years' Marine Corps service, General Smith led the First Division during the Inchon amphibious landing, the Seoul conquest, and the famed Chosin Reservoir withdrawal. He returned from Korea last May to take charge of Camp Pendleton.

Many Servicemen's Bills Introduced At Solon Session

Needs and concerns of servicemen bulk large in legislation facing the new Congressional session. Among bills recently introduced are the following:

- 1. Extension of educational benefits of the Serviceman's Readjustment Act of 1944 to personnel of the Armed Forces who served on or after June 27, 1950.
2. Amendment of the UMTS Act of 1951 to provide that certain members of the National Guard and other reserve components who served during World War II be released from active duty after 17 months' service.
3. Pensions for widows and children of deceased World War II veterans or veterans of service on or after June 27, 1950 on the same basis as widows and children of World War I veterans.
4. Provision for administration and discipline of the National Security and Training Corps.
5. Lifetime pensions of \$100 a month for winners of the Congressional Medal of Honor or their survivors.
6. Maternity and infant care and hospital care for dependents of enlisted personnel of the Armed Forces.

Laundry Marking Regs Violated

All personnel sending clothes to the Camp Laundry are instructed to have all items plainly marked with the SENDER'S NAME ONLY, according to a recent camp memorandum. The practice of sending several persons' clothing in a single bundle is causing unnecessary difficulty in establishing ownership and assembling of clothing.

Articles containing markings of a person other than the sender will be separated from the bundle without being laundered and held until called for.

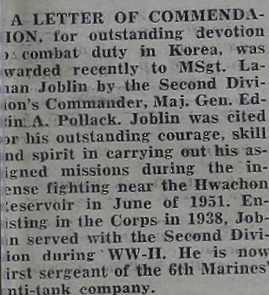

Hospitalized Korean Vet Gets Double Dip—Bronze Star And Fourth Stripe

SSgt. Robert G. Skidmore, hospitalized for wounds received in Korea, got the full treatment last week—he was presented a Bronze Star Medal and his promotion to staff sergeant at the same time. Occupying Ward 22 at the U. S. Naval Hospital here, Skidmore accepted the dual presentation from Col. J. A. White, Commanding Officer of H&S Bn., Marine Barracks, while literally flat on his back.

While serving with the First Marine Division in Korea, Sergeant Skidmore successfully rescued his battalion commander and executive officer, who were both wounded. He took them to an aid station in an ambulance under a heavy mortar barrage. He was awarded the Bronze Star for that action. Wounded twice at separate times in the campaign, he holds two Purple Heart Medals.

All tests or examinations for his promotion were waived because of his hospitalization and resulting inability to take them. At present he is a member of Motor Transport Company, Marine Barracks.

Chaplain's Corner

Question Mart

(This is the GLOBE's question and answer department. Accurate, authoritative answers will be provided, if at all possible, for your professional questions. Q. I was with the Fourth Marine Regiment in the Philippines at the outbreak of WW II, and, after capture spent the rest of the war as a "guest" of the Emperor. What ribbons do I rate? J.F.B.

A. All personnel who served with the Fourth Marines in the Philippine Islands from December 1941 to May 1942 are entitled to wear ribbon bars representative of the following awards: Army Distinguished Unit Emblem with Oak-leaf surmount; American Defense Service Medal with Base clasp; Asiatic-Pacific Campaign Medal with one bronze star; Victory Medal World War II and the Philippine Defense Ribbon with one bronze star.

Q. What would happen to me if, while on leave or liberty, I were arrested by civilian police for an offense, confined for a period of time, but acquitted by the judge when case came to trial, however WOL or AOL back at camp because of being confined awaiting trial? R.E.L.

A. When a member of the armed forces, on authorized leave or liberty, is held, tried, and acquitted by civilian authorities, his status of absence with leave or liberty is not to be changed, regardless of how long he was held before the acquittal. If a member of the armed forces, on authorized leave or liberty, is convicted by civilian authorities, the fact that he was arrested, held, and tried, does not excuse any period of time for which he was unauthorizedly absent. A general rule to remember is: Where a man is on authorized leave or liberty, and he is unable

to return at the expiration thereof, through no fault of his own, he has not committed the offense of Absence Without Leave, since he has an adequate excuse for such absence.

Q. While on authorized leave I came involved in a fracas in which a police officer is assaulted. I am convicted by a civil court and sentenced to five days confinement but serve my sentence and return to camp prior to expiration of my leave. Can my C.O. award me some sort of court martial because I have been guilty of assaulting a police officer, even though I have already served a sentence in the civilian court? P.T.Z.

A. Members of the military service are answerable to two separate authorities, civil and military. It is quite possible, therefore, for an individual to commit one offense and to be held answerable to both such authorities for one crime. Therefore, in the above question, a member of the military, who would so conduct himself on leave as to wrongfully strike an officer of the law, could be tried, convicted, and sentenced for the civil offense of assault and battery, and upon his return to military jurisdiction could be further censured or punished for bringing discredit upon the military service by such conduct. As a practical matter, however, most commanding officers feel that that "one pound of flesh is sufficient for each crime", and no further action will probably be forthcoming. But, don't depend on it.

to the nearest village, marched down a street and annihilated the first 50 Lithuanians living there.

"The most gruesome attack of the Germans in Lithuania was the slaughtering of 200,000 Jews," said Reventas.

The Russian armies swept back into Lithuania again in 1944. Reventas and his family fled to Stettin, a large German port on the Baltic Sea. In Stettin they were again captured by the Russians.

A week later the Germans recaptured the port of Stettin. This time the Reventas family fled to Hamburg where they were liberated by the British in 1945.

Reventas was graduated from a Lithuanian refugee high school in 1947. He attended the University of Hamburg in 1948 and Brooklyn College in 1949 where he was majoring in chemistry when drafted.

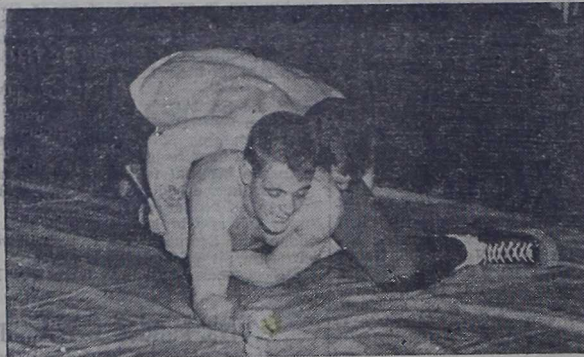
