Clean up of radioactive material at the Shallow Land Disposal Area (SLDA) in Parks Twp, Armstrong Co

There have been many cover-ups and disappointments in the long road to determine the extent of the problem here and to make appropriate judgements about the best way to handle the clean-up of these deadly materials.

This community and its elected officials have found the Pittsburgh District of the Army Corp of Engineers to be honest with us about the clean-up effort and we want this Corp to maintain total jurisdiction and control of the SLDA under the program known as FUSRAP or Formerly Sites Remedial Action Program. We do not want to give control of this project back to the NRC and BWXT.

We also request that the Army Corp extend the tours of duty of Colonel William Graham and Major Robert Elliott, so that the clean-up can proceed with the benefit of their valued knowledge in the hope that we can avoid further regulatory mishaps.

Because of the misrepresentations by former companies and agencies, the Corp has set out to evaluate the true extent of contamination. It is imperative that the responsible parties be held at arms length for purposes of this evaluation, but that they be held accountable for the costs of the remediation.

Our homes have been devalued, the very existence of our businesses threatened. This site must be cleaned up in such a way as to safeguard our people and restore our economic health. If this cannot be accomplished, then the parties responsible must make us whole. These companies made their money at the expense of the health and even the very lives of the people we loved who came before us. We should not still be footing the bill, nor should our children.

As a final consideration for the well being of this community, I request that the Federal Protection Service under Homeland Security remain until the clean-up project is complete. And we ask that the EPA and PA Dept. of Environmental Protection have *voices in this matter. Transparency is a must and a right of the people. Test our air,* groundwater, springs, aguifers, river and vegetation on a regular basis.

We have paid such a heavy price. We must demand our rights to live in our community without the threat that radioactive exposure brings to us and to our children.

From the time he assumed command, Col. Graham has kept our community informed about this project through a continuing series


of public meetings and has answered questions about our concerns. More importantly, at every meeting he emphasizes that his highest priority is safety for the workers, for the community and indeed for all involved plus his commitment to achieve a complete removal of

all material of concern. He has demonstrated his dedication to safety by stopping the project at the first sign of a safety violation and has personally assured us that work will not begin until the problems are understood and corrected. We thank him and feel confident he will continue to put "safety first".

The comments below primarily address issues of safety.

 That ACE authorizes the continuation of research effort to further identify nuclear materials of concern. The latest research contract was cancelled by the prime contractor after excavation work was terminated and before research could begin. Since safe handling and transportation procedures vary according to the identity and amounts of expected isotopes, additional knowledge should provide additional safety.

- That the communication links between the contractors and the Corps is constant and seamless to identify and anticipate any further unsafe complexities.
- 3. That qualified former NUMEC personnel be used to identify excavated materials before safely moving it from the burial site.
- That the selection criteria for contractors not only include examples of previous successful management and conduct of similar remedial projects, but also include information demonstrating a priority commitment to safety for those projects.
- 5. That the contracts with the contractors be other than "Fixed Price" to discourage the use of "short cuts" and other unauthorized means to reduce costs at the expense of safety.



Army Corp of Engineers Fight for Us


We need an unbiased party to be taking on this huge responsible to make sure it is done in an efficient, thorough and most importantly safe manner.

Exemption #6 - privacy Ladies and Gentlemen, my name is **Exemption**, and I submit this testimony today representing the Allegheny Township Board of Supervisors

It is extremely important for me to emphasize the importance of geography as it relates to economic development for any community. Our land's value is subject to the neighbors we have and how well they keep their property. If our neighbors have a junk yard, our property value decreases, likewise, if our neighbors have a well kept piece of property our land becomes more valuable and sellable. I give this analogy to make a point. Although we have all been victims of this nuclear dump site, it has been in very good hands with the Corps of Army Engineers. They very competently have been working diligently to remove our proverbial "junk yard" so that the future economy of the Valley becomes stable once again, not only for Parks Township, but for its neighbors as well.

Allegheny Township has had experience with the Corp working in our community. In 2005 a cleanup of the Kiski Valley Water Pollution Control Authority Lagoon was completed with the Army Corp at the helm. We were able to see first hand the level of skill, expertise and care that was used to finish that project, all the while maintaining the community as the focus of the project. They kept residents well informed, exercised great safety and care in utilizing our roads and expeditiously completed the project for the betterment of all. The Corps has been managing the Parks project in a similar manner. With the Comprehensive Environmental Response, Compensation and Liability Act (CERCLA) process, the Remedial Investigation, Feasibility Study, Proposed Plan, and Record of Decision (ROD) all being completed to date, removal of their expertise from this project at this point would be a devastating blow to our community likely resulting in many additional years to complete this remediation. If we are ever to hope that this property once again becomes a viable piece of the economic puzzle, we need to keep moving forward on the path that has currently been in place. Parks Township's ability to have this property's needs addressed is critical to all of our local elected officials. We all work to make our communities thrive, residentially and commercially, so being in direct proximity to this site absolutely effects the economic well being of Allegheny Township. With their success comes our success

The economy in our area is strictly and directly tied to environmental impacts by the way in which we manage our water resources in improving the quality of our citizens' lives. It has affected where and how people live and influenced the development of this country including the Kiski Valley. Our country today seeks economic development as well as the protection of

environmental values. They are key partners in economic development initiatives. Nothing should happen on this property that would further jeopardize the tax base with stagnant remediation or backwards remediation.

As we look into the future of this site and the region, we do know that there are challenges and opportunities. As we recover from this economic downturn, we must make investments and assurances today to address the realities of the future. It has been a slow climb out of this recession but we are well up the ladder in our recovery. Any change to how this property is being currently handled is certain to knock us back toward the bottom.

The local Elected Officials would like to see The Corps of Engineers be committed to staying at the leading edge in service to this project. In support of that, we are working with other local officials to transform our regional communities into destinations spots to further commerce, enhance residential neighborhoods and provide quality infrastructure. We're committed to a process that leads to open and transparent modernization, as well as a performance-based project that only the Corps of Army Engineers can provide.



The Army Corp of Engineers has done a fine job, but They can not change what is in that ground and how it effects peoples health.

If you move the people out by buying them out like Centrailia, Pa. the people would at least have a chance to be safe. Once there is an accident and there already was an accident there is nothing you can do after exposed to radiation.

It will end up like Chernoble. I have a beautiful home and I would hate to loose it, but my families health is more important. This is so sad.

Please consider moving the people out. Once you have them out you will have the whole territory To yourself and guards.

The Parks Township nuclear waste dump question (and related issues such as healthcare and former worker compensation) will remain unanswered until it is properly addressed. The organization and individuals responsible for creating the problem—the Nuclear Materials and Equipment Corporation—have not been placed in proper context or held accountable.

NUMEC shares the heritage of a peculiar type of organization. Materials for Palestine, Foundry Associates,

Service Airways, Mar-Tech, Heli Trading Company, Milchan Brothers, MILCO, Telogy are all front companies that were formed to illegally ship military goods to Israel. The last four were involved in nuclear technology smuggling. NUMEC was created for the same purpose as Zalman Shapiro, former smuggler David Lowenthal, and other key organizers worked to gain access to AEC-regulated weapons-grade uranium to divert to Israel.

The Army Corps of Engineers has confirmed receipt of my comprehensive study (Divert! NUMEC, Zalman Shapiro and the diversion of US weapons grade uranium into the Israeli nuclear weapons program) tracing NUMEC's origins, operations, and employee affidavits to the FBI that Zalman Shapiro stuffed canisters of U-235 into irradiator equipment shipped to Israel. We offer as many complimentary copies as you require. Once the core purpose of NUMEC, a suspiciously undercapitalized business established in highly inappropriate facilities, is grasped it becomes obvious that the former plant sites in Apollo and the Parks Township are not toxic pollution sites—they are crime scenes.

If a bona fide investigation and timely prosecutions had ever taken place-a 1978 GAO report <http://irmep.org/ila/nukes/NUMEC/default.asp> affirms such accountability was thwarted-much of the fallout could have been avoided. This includes the AEC pressuring an oil company to acquire NUMEC in 1967 in exchange for Hanford management contracts, and Babcock and Wilcox taking over to maintain a flow of U.S. Navy contracts. These transactions would not have happened but for deep corruption within the AEC, which thwarted warranted investigations, even after traces of divert NUMEC uranium were picked up in Israel. In a perfect world, compensation for the NUMEC disaster would be paid by the very same Americans who improperly profited from it (Zalman Shapiro, David Lowenthal, Leonard Pepkowtiz, and Frederick Foerscher.) Under a just outcome, the cost of cleanup and health-related compensation would be borne by the Israeli Atomic Energy Commission (the Israeli weapons-development front organization which had a joint venture, ISORAD, with NUMEC) and the Israeli government. US organizations on the periphery that provided political and two directors to NUMEC, such as the Zionist Organization of America, would now defray the massive costs. As a final gesture, stolen U-235 enough for many weapons, would be publicly returned to the US by the leader most responsible for its theft-Shimon Peres.

What dangers lie beneath the soil in the Parks Township dump are unknowable, because every organ of the US government that dealt with the NUMEC question, the AEC, FBI, CIA, Justice Department, presidents from Johnson to Carter, the NRC, Joint Committee on Atomic Energy and others utterly failed to resolve it. Victims have understandably directed their efforts against the deepest pockets, such as the Congress and companies left holding the NUMEC bag (ARCO and B&W Technologies). Meanwhile, a great deal of useful classified information generated by the CIA, FBI, NSA, National Archives Presidential Libraries and other entities remains classified. As we've already communicated declassified files of a 1969 spill caused by Shapiro and Lowenthal's negligence, this information could help lower costs and improve safety, but only if it is fully declassified and transferred into the public domain.

In summary, the former NUMEC properties are crime scenes. No act was too criminal, heinous or negligent for its owners to engage in to achieve their clandestine designs. This is abundantly clear to any who read "Divert!" or consult the key documents with an open mind. (see http://www.irmep.org/ila/numec) Until there is a bona fide effort to release classified information about unprosecuted crimes and seek restitution from the true perpetrators through an open truth and reconciliation process, the US Army Corps of Engineers will become the latest patsy in a cruel atomic game of musical chairs when NUMEC's discordant tune again grinds to a halt.

On behalf of the citizenry and local governments of the Kiski Valley, past, present and future and on behalf of the citizenry of Pennsylvania; in an attempt to have 'equal access to justice' and for the protection of our health and safety as a necessity; for the environment that sustains us through our water, vegetation, soil and air as a necessity and for the survival of our economic structures, present and future as a necessity; I make and enter for the record, the following requests as a necessity, regarding the fate of the clean-up of the Shallow Land Disposal Area.

1. That the Pittsburgh District of the Army Corps of Engineers maintain total jurisdiction, control and clean-up authority of the SLDA under the Formerly Utilized Sites Remedial Action Program (FUSRAP) for a safe and comprehensive clean-up of all contaminated wastes without threat of giving the license back to the NRC and BWXT; and that the clean-up process resume as expediently as possible.

2. That we understand that as a provision of the FUSRAP program, the Corps will recoup from the responsible parties (ARCO and BWXT), the clean-up costs to reimburse the taxpayer's coffers, thus eliminating the budgetary issues.

3. That given the history of misrepresentations made regarding the SLDA by ARCO and BWXT and by the AEC/NRC agencies previously involved; that the Corps set out to evaluate the totality of the original deeded property outside the fence line for possible burials to include areas within the abandoned coal mine.

4. That because there needs to be an evaluation for the potential of state and federal violations of environmental laws, the responsible parties, ARCO and BWXT, must be removed as 'stakeholders' regarding any input or involvement in dealing with the fate or clean-up of the SLDA and replaced by representation of local government and citizens.

5. That the Department of Justice (DOJ) and the Environmental Protection Agency's (EPA) investigative branches be included and implemented each as a 'stakeholder' to ensure all legal avenues within the laws are investigated, met, negotiated and represented.

6. That there be no activity that would undermine our entire sustaining economic structures and taxed-based revenue in addition to property value depreciation.

7. That transparency is a must and a right of the people.

8. That this site be cleaned up to the ability of being a future revenue generating property without the threat of indemnifications; and if that cannot be done, that the responsible parties, ARCO and BWXT, be held accountable to at least the tax base as if all structures were still present encompassing the area of the original deeded property.

9. That the Federal Protection Service under Homeland Security remains until the project's completion.

10. That testing of the groundwater, springs, aquifers, river and vegetation are done on a regular basis.

11. That the Pennsylvania Department of Environmental Protection (PaDEP) has a voice as stakeholders.

12. That every precaution for public and environmental safety be constructed and implemented.

13. That it is respectfully requested of the Secretary of the Army and the Commanding General and Chief of the Army Corps of Engineers, that the tours of duty of Col William Graham and Major Robert Elliott, be extended so that this project, which has been seriously delayed by circumstances not of their doing, can progress with their valued knowledge and be well underway so that a smooth transition without further regulatory mishaps will occur upon change of command. Furthermore, if ever there has been any semblance of trust in a governmental agency from this community regarding our nuclear legacy, it is in the Pittsburgh District of the Army Corps of Engineers solely because of these two officers.

Lastly, our valley was proud to serve our country as Veteran Civilian Soldiers, but because of this, we have dealt with torturing issues at the hands of the companies and the AEC/NRC, who failed to regulate, especially with public safety in mind. We have dealt with loss of life, loss of health, loss of property values, and yes, even loss of ground. We have suffered, we have cried, we have grieved and we have yelled out for help. None came until Jack Murtha wrote into law the legislation that gave the Army Corps of Engineers the jurisdiction over the SLDA site. Now then, do you leave us on the battlefield or do you fight for us and live up to your motto: "The difficult we do immediately, the impossible takes a little longer" Essayons!
